# **Participant Orientation**

- Report to Room 116. A Fashion Show staff member/runner will direct you to your room when it is time. Look for the person with a clipboard.
- Relax and be confident. This is your time to tell the judges about clothing and textiles experiences.
- Be aware of the person who is scheduled before you in the judging order. Times are approximate.
- Enter the judging room.
- Introduce yourself. Include your name, your county, years in clothing project and fashion show.
- Judges will ask you questions. Please answer only the question that you are being asked. You have five minutes with judges.
- At the end of interview model your outfit for the judges. The judges will learn about you from your entry paperwork as well.
- Thank the judges for their time and shake each judges hand.
- Have fun.

# Judges' Orientation

- Please arrive on time so that you will have time to preview all entry paper work prior to interviews.
- The Fashion Show participant will enter judging area. They will tell you their name, their county, their years in the clothing project and years in the Fashion Show.
- Please do not allow formal presentations, instead ask the standard questions. This process should take five minutes. You will have a timekeeper assigned to you.
- At the end of the question and answer portion. The 4-H member will model their outfit for you.
- Please be very supportive of the young person and provide feedback to let them know their strengths and weakness pertaining to clothing and textiles and their grooming.

# Judges' Orientation

- Provide numerical scores in the actual score column of the score sheet. You will not have to total your scores. We have tabulators. One of the co-chairs will collect the score sheets every so often. You will not hold on to them until the end of the contest. There is not a need to collaborate with the other judge on final placing since we are using numerical scores.
- Please initial your score sheet in case the tabulators have questions or in the event of a tie. The score will be cut off of the score sheet before they are returned to contestants.

# **Standard Buying Questions**

1. What occasion could you wear your outfit?

2. What is the fiber content of your garment? Tell me qualities of each fiber.

- 3. Are the fibers in your garment natural or man-made?
- 4. How should you care for this outfit?
- 5. What did you consider when buying this outfit?
- 6. How does this outfit meet your clothing needs?
- 7. Explain how and why the style of this outfit is appropriate for your figure type.
- 8. Are there any changes you would make to improve the fit?
- 9. Explain what you considered when choosing your accessories.
- 10. What skills did you learn while shopping for this outfit?
- 11. Describe your clothing and textiles leadership activities? What was your favorite leadership activity?
- 12. Describe your clothing and textile project community service?

### **Standard Construction Questions**

1. What occasion could you wear your outfit?

2. What is the fiber content of your garment? Tell me 2 qualities of each fiber.

3. Are the fibers in your garment natural or man-made?

4. How should you care for this outfit?

5. What type of weave or knit is your fabric? What are the characteristics of this weave?

6. How did you decide which sewing methods to use for seams, hems, etc.?

7. When shopping for fabrics, notions, and patterns, what did you consider?

8. Why did you choose to construct this garment rather than buy it?

9. Are there any changes you would make to improve the fit for your body type?

10. Explain what you considered when choosing your accessories.

11. Describe your clothing and textiles leadership activities

12. How did you connect your clothing and textile project work with community service?

13. Model your outfit.

### **Natural Fibers Contest**

 Each contestant will do an introduction to a panel of judges. Then will be prompted to present your 1 to 2 minute commercial promoting your natural fiber. Props are permitted. Judges will conclude with questions about the commercial and entry form responses. Participants will be scored on the knowledge of their natural fiber on the natural fibers score sheet.
